

COOKIES POLICY

Alumetal S.A.

1. **Alumetal S.A.** does not collect any information through the Website automatically, except for the information contained in cookies.
2. **Cookies** are computer data, in particular text files, that are stored in the end device of the Website User and are intended for using the website. In most cases, cookies contain the name of the website to which they are assigned, their storage time on the end device and a unique number.
3. The entity that places cookies on the Website User's end device and obtains access to them is the Provider of this Website: **Alumetal S.A.** with its registered office in Kęty, ul. Kościuszki 111, 32-650 Kęty.
4. User data received through the **Alumetal S.A.** corporate website are intended exclusively for use by **Alumetal S.A.** or subsidiaries of **Alumetal S.A.**
5. The data controller is **Alumetal S.A.** with its registered office in Kęty, ul. Kościuszki 111, 32-650 Kęty.
6. **Alumetal S.A.** Uses technical and organizational measures to ensure the protection of the processed personal data processed and to secure the data against disclosure to unauthorized persons, collection by an unauthorized person or processing in breach of the Personal Data Protection Act.
7. Cookies are used to:
 - adjust the content of the website to the preferences of the Website User and optimize the use of the website; in particular, cookies allow to recognize the device of the Website User and to display the Website according to his/her individual needs;
 - develop statistics to determine how the Users use the Website to improve its structure and content;
 - keep the Website User's session (started with his/her logging in) so the Website User does not have to repeat the login activities on each subpage of the Website (i.e. enter login and password).
8. The Website uses two main types of cookies: "*session cookies*" and "*persistent cookies*". Session cookies are temporary files that are stored on the User's end device until he/she logs out, leaves the website, or turns off the software (web browser). "Persistent" cookies are stored on the User's end device for a period of time specified in the cookie settings or until they are deleted by the User.
9. The Website uses following types of cookies:
 - "**necessary**" cookies enable the use of the services provided on the Website, which in particular include authentication cookies used for services that require authentication on the Website;

- security cookies, e.g. used to detect fraud in the scope of authentication on the Website;
- "performance" cookies to collect information on the use of the Website.
- **"functional" cookies** provide a "storage" of the settings selected by the Website User and a customized Website User interface, such as the selected language or region of the Website User, font size, display of the Website, etc.;
- **"advertising" cookies** ensure the provision of advertising content to the Website Users that is more tailored to their interests.

10. In many situations, the software of browsers (web browsers) allows cookies to be stored on the User's end device by default. The Website Users can modify the settings of approved cookies at any time. These settings can be changed in particular in such a manner to block the automatic cookies in the web browser settings or to notify the User whenever they are stored on the Website User's end device. Information on how to change cookie settings in the most popular web browsers can be found further section. Detailed information on the methods and options how to handle cookies is available in the software (web browser) settings and in the help files available in the browser menu.
11. **Alumetal S.A.** hereby declares that the failure to use the recommended cookies may be significant when using the Website. The Website Provider informs that restrictions on the use of cookies may affect some of the functions available on the Website.
12. Cookies stored on the Website User's end device may also be used by advertisement providers and partners cooperating with the Website Provider.
13. Personal data collected using "cookies" may only be collected for the purpose of performing certain functions for the benefit of the Users. Such data shall be encrypted in a way that prevents unauthorized access.
